Bioekvivalensstudier, hentet fra Assessment report	<p>Ingen BE-studier: Adapalene/Benzoyl peroxide Orifarm is a product for topical application and for locally applied products, pharmacokinetic bioequivalence studies are generally not a suitable way to show therapeutic equivalence, since plasma levels are not relevant for local efficacy, although they may play a role with regard to safety. For this product conventional pharmacokinetic bioequivalence studies are not relevant due to low systemic exposure to adapalene and benzoyl peroxide. The absence of pharmacokinetic studies is acceptable.</p> <p>The applicant applies for the following indication: Cutaneous treatment of Acne vulgaris when comedones, papules and pustules are present (see section 5.1). Adapalene/Benzoyl peroxide Orifarm is indicated in adults, adolescents and children aged 9 years and over.</p> <p>Therapeutic equivalence has been demonstrated between the test product and the reference product Epiduo®, and superiority versus placebo was shown. No new adverse events were observed except for those previously known with the reference product Epiduo® 0.1%/2.5%.</p> <p>The SmPC texts proposed for Adapalene/Benzoyl peroxide Orifarm is identical to that of the reference product and is accepted.</p>
